Overview of FET

CMETB Further Education and Training (FET) Services provide a wide range of full and part time programmes throughout Cavan and Monaghan, offering valuable learning opportunities for those over 16 years of age. The programmes are largely vocational in nature, e.g. childcare, healthcare, ICT, engineering, thus providing clear routes into employment. Likewise, there are a number of progression opportunities from FET programmes into Higher Education (e.g. Universities and Institutes of Technology programmes).

CMETB FET comprises 5 distinct services:

- Two PLC Colleges Cavan Institute & Monaghan Institute delivering full time vocational skills programmes at Levels 5 & 6 and evening classes
- Adult Education Services delivering a range of part time basic and vocational skills and hobby programmes at levels 1- 6
- **Training Services** this includes the Apprenticeship Service, Specific Skills Training Programmes, Traineeships, Local Training Initiatives & Specialist Training Providers

- **Youthreach** 6 Youthreach Centres that provide a broad range of certified programmes for early school leavers
- Prison Education at Loughan House Open Prison

The services work in collaboration with all stakeholders, particularly learners, employers, community & voluntary sector and public authorities in the development and provision of programmes to: (i) meet emerging education, training and employment requirements and trends, and (ii) support learners to realise their potential.

New Initiatives / Developments

Programme Provision

- PLC Access course based in MI & CI for Youthreach and LCA learners to complete a full Level 4 and some Level 5 modules, in preparation to transfer to MI / CI next year.
- Youth work traineeship to commence in Cavan Institute
- Domiciliary Care traineeship to commence in Cavan Institute
- Architectural Technology Traineeship Level 6 (Entekra) traineeship to commence in Monaghan Institute
- OEM Apprenticeship to commence early October commence in Monaghan Institute
- Electrical Car Charger installation and Portable Appliance Testing programmes to commence in FET Campus
- #Intoajob This programme ran during the summer with 38 learners between the ages
 of 16 and 19 completing a range of certification options including Safepass, First Aid,
 HACCP and non-accredited programmes in Safety and Health at work, Restaurant and
 Bar Skills, CV preparation and Interview Skills. It is hoped to extend this programme to
 the YES group identified by DEASP.
- Fit for Work and Life: this programme runs in conjunction with the Irish Cancer Society and aims to assist participants to make positive lifestyle choices. It is hoped to have 2 tutors trained up (1 Monaghan and 1 Cavan) to roll out this programme through adult education services
- Seed to Market: Community Education Services are working on a project in Cavan by bringing together local growers and markets and the provision of business, horticulture and marketing skills to make these markets viable

New Linkages / Partnerships

- LYIT degree: Working with LYIT re bringing their Level 7 degree in Health and Social Studies to MI on an outreach basis, starting in late September
- Sligo IT: Working with Sligo IT re bringing their Science degree to CI on an outreach basis
- New linkages with a range of employers under Skills to Advance programme

Progress:

Since the Board last met the following should be noted:

- A two-day Leadership Conference was provided by CMETB for school leaders in June 2019.

 received the highest Leaving Certificate points in their recent exams and for the students with
