

As requested at a previous meeting Carrickmacross Youthreach Co Ordinator Bernadette Duffy and Kingscourt Youthreach Co Ordinator Michael Murphy joined the meeting to give a presentation on the work completed by Youthreach Centres (See **Appendix A**). The Coordinators outlined how Youthreach can support early school leavers by offering nationally recognised qualifications in a safe and supported environment. Youthreach aims to support Social Inclusion, aiding progression into further education, training opportunities and entry into the labour market. Youthreach also works to promote and enhance personal and social development and to increase self-esteem of the learners. There are currently 175 Youthreach places within CMETB across 6 centres: Carrickmacross, Castleblayney, Cavan, Cootehill, Kingscourt and Monaghan. Co Ordinator Bernadette Duffy confirmed Carrickmacross Youthreach will move to a new premises on Main Street Carrickmacross.
